


# **Background**

- The National Strategic Plan on AMR in Lao PDR (2019-2023) for AMR surveillance system in Lao PDR includes AMC and AMU
- National AMC Focal Point has been established
- Translation, Dissemination, and Distribution of the AMC Manual and Guidelines
- Provided 1 Computer to each participating hospital
- Main Funded by KOICA/WHO


Lao Population Projections 2015-2045



# Implementation of AMC monitoring (Hospital Level)

- First Workshop and training in 2018 to 5 Central Hospitals and 3 Provincial hospitals
- Start to collect National AMC data since 2018
- Conducted Close monitoring and on-site training for all participated sites
- As of 2023, the AMC monitoring training has been completed in all 17 provinces. AMC monitoring is currently conducted in 22 sites (5 central hospitals + 17 provincial hospitals).
- Calculation of AMC data Year 2018, 2019, 2020, 2021 and 2022 have already shared with the WHO WPRO for reporting to GLASS at the global level













# Challenges

- Limited human resources
- Low Awareness of some Hospitals regarding to timeline of submission of AMC data
- Limited AMC data from private sectors
- Weak enforcement of the existing laws/regulations
- Limited support and motivation





#### **Future Plan**

- Annual AMC workshop and back to back lessons learned workshop for Good Hospital Pharmacy Practices (GHPP)
- Integration AMC methodology compliance to GHPP
- Implement the project of Good Pharmacy Practice in private pharmacies in order to scale up the coverage of AMC data and mitigate the AMR regarding to inappropriate dispensing of AM
- Close monitoring of AMC data in subsequent years for further assess its impact of COVID-19
- Continuous capacity building by existing budget and mechanism
- Scale up AMC monitoring in private sectors.
